### The Information We Collect

The only time CASA for Kids of East Texas will ask for your personal information is when you register with us to make an online donation or register for an event. During this process, CASA for Kids of East Texas may ask for one or more of the following: your name, guest name, organization, address, city, state, zip code, phone, fax, email, gender or birth date.

We will store that information in our database to add you to our mailing list so that we can send you information about CASA for Kids of East Texas.

Typically the mailing list would be used initially for recruitment or fundraising events and programs that benefit and support the mission of CASA for Kids of East Texas. If you do not wish to receive such solicitations or notices, you will need to inform us separately that you do not wish to receive such information. In addition, if you contact CASA for Kids of East Texas, we may keep a record of that correspondence. If at any time, you no longer wish to receive e-mails from CASA for Kids of East Texas, please let us know.

#### **Our Commitment to Security**

CASA for Kids of East Texas operates secure data networks protected by industry standard firewall and password protection systems. Our security and privacy policies are periodically reviewed and enhanced as necessary and only authorized individuals have access to the information provided by our users.

To protect your information off-line, we have put in place appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect from you online.

#### **Our Commitment to Children's Privacy**
